Resolution No. 123 of 2010, a resolution accepting a quote for professional appraisal services for the Clifton Knolls Executive Golf Course.

Introduced by Councilman Hughes, who moved its adoption, seconded by Councilman Paolucci.

WHEREAS, the Town wishes to explore the feasibility of the purchase of the Executive Golf Course at Clifton Knolls, and

WHEREAS, quotes were received to conduct a real estate appraisal and evaluation report of the Clifton Knolls Golf Course under consideration for potential acquisition by the Town of Clifton Park, and

WHEREAS, Thomas McCarthy, Town Attorney, has recommended that the quote of Upstate Services, 1795 Route 9, Clifton Park, New York, be accepted as the lowest responsible quote, and

WHEREAS, this resolution does not bind the Town to any decision regarding the possible purchase of this property, but provides the Town with necessary information regarding potential values; now, therefore, be it

RESOLVED, that the quote of Upstate Appraisal Services Inc. be accepted in an amount of \$1,900; and be it further

RESOLVED, that the Supervisor is authorized to enter into an agreement or engagement letter with Upstate Appraisal Services Inc. at a cost not to exceed a total expenditure of \$1,900 for an appraisal report to be paid from Contingency.

Supervisor Barrett reported the town engineer has done a basic overview of the facilities, e.g. equipment, sprinkler system, fencing. Town Attorney McCarthy said the President of Upstate Appraisal Services is familiar with the property. The Supervisor said the owners of the property have given the town first right of refusal.
